

Cockburn Mystery Cash Case Competition – Terms and Conditions

1. These Terms and Conditions apply to the Cockburn Mystery Cash Case Competition which has been issued by Perron Investments Pty Ltd (ACN 000 003 976) Cockburn Gateway Shopping City, 816 Beeliar Drive, Success WA 6164.
2. This competition is open to shoppers over the age of 18 [or over the age of 16 with the consent of a parent or guardian] at Cockburn Gateway Shopping City during the promotion period.
3. Information on how to take part and prize allocation form part of these terms and conditions, and by entering the competition, all entrants agree to these terms and conditions.
4. The promotion commences at 8:00am on Monday, 15 November 2021 and concludes at 3.59pm on Sunday, 28 November 2021.
5. To enter, shoppers must spend at least \$30 in a single transaction in Centre at Cockburn Gateway Shopping City at participating retailers. For every \$30 they spend in each single transaction, entrants will receive 1 x entry form. They must complete each entry form and insert the completed form in the prize barrel located at the Mystery Cash Case competition stage outside of Big W at Cockburn Gateway Shopping City. Only the amount spent in each separate transaction will determine whether an entrant is entitled to one or more entry forms, and amounts spent on multiple transactions, cannot be combined to receive additional entry forms.
6. No responsibility is accepted for late, lost or misdirected entry.
7. Three draws will take place at 12pm, 2pm and 4pm on Sunday 28 November on the stage outside Big W at Cockburn Gateway Shopping City. At each draw, an entrant will be drawn from the barrel and announced over the Centre PA system. They will have two minutes to report to the stage with identification proving their identity, to be invited to participate in the competition game.
8. If an entry form is incomplete, then this entry will be rejected as invalid and a redraw will take place. If the details on the entry form do not include a first name and surname and a valid email address or mobile phone number, they will be considered to be incomplete.
9. If at the end of the timed two minutes, the drawn entrant has not reported to the stage the entry will go back into the barrel and a redraw will take place. This process will be repeated until a selected entrant, successfully reports to the stage with identification within the time limit from the announcement of their name.
10. Once the entrant is on stage and has been successful identified and their eligibility confirmed, they will be invited to participate in the competition game. The competition game, will consist of nine unmarked suitcases with differing cash amounts printed on the inside, positioned in a 3x3 grid. The entrant will be required to select one of three briefcases, from each of the three columns, to reveal their accumulated cash prize.
11. The prize pool is made up of:
 - 2 x \$5,000 suitcases

- 1 x \$4,000 suitcases
 - 4 x \$3,000 suitcases
 - 2 x \$2,000 suitcases
12. Once the prize amount is determined, the winner will be provided with a letter of confirmation from the Centre which will include details on how the funds will be transferred to the winner electronically, by 31 December 2021. In order to claim the prize and have the funds transferred to the winner, the winner must provide Centre Management with their bank account details with an Australian bank. The funds will be transferred to the nominated bank account, and Centre Management and the promoter will not be responsible for any error in the bank account details provided to Centre Management.
 13. The prize can only be taken as supplied and cannot be exchanged or modified.
 14. All entries become the property of Cockburn Gateway Shopping City. Cockburn Gateway Shopping City may use the name, address and other personal information provided by the entrant for the purpose of the competition, and the bank account details of the winner for the purpose of awarding the prize. Details will not be provided to a third party (other than account details to the Centre's bank for the purpose of payment of the prize), or if you elect to receive marketing materials from us.
 15. Cockburn Gateway retailers, management, their staff, associated agencies and their immediate families are ineligible to participate in the promotional giveaway.

The entrants and winners release from, and indemnify Cockburn Gateway Shopping City, Perron Investments Pty Ltd and JLL against, all liability, cost, loss or expense arising out of acceptance of any prize(s) or participation in the promotional giveaway including (but not limited to) loss of income, personal injury and damage to property and whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise.
