Cancellation Deadline:

Bookings may be rescheduled or cancelled until 48 hours before the start time of the Colour Edit event, no later than 12pm AWST on Tuesday 19 May 2026. Beyond this time, bookings cannot be rescheduled and are non-refundable.

Non-Refundable Policy:

Refunds are managed through Humantix. After the cut-off time specified above, refunds will not be provided, inclusive of:

- a) Change of mind
- b) Incorrect booking selections
- c) Failure to attend the appointment
- d) Late arrival
- e) Inability to participate due to personal circumstances

6. Rescheduling & Transfers
